1. Circle Internet Financial, LLC was party to that certain Master Services Agreement, dated 9/13/21 between it and the INTERIM GOVERNMENT AND THE NATIONAL ASSEMBLY OF THE BOLIVARIAN REPUBLIC OF VENEZUELA. The agreement was extended by amendment and expired on 12/31/2022. The amount of fees collected during the term of this agreement was \$62.491.67.

2. Circle Internet Financial, LLC was party to that certain Circle Business Account Order Form, dated 9/2/20 between it and the THE BOLIVARIAN REPUBLIC OF VENEZUELA. This agreement expired on 9/2/21. The amount of fees collected during the term of this agreement was \$72,000.

These 2 agreements were accompanied by OFAC permissions to move certain blocked funds in US bank accounts as a part of a Venezuelan humanitarian aid project.
