

**AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 1713
OFFERED BY MR. LUCAS OF OKLAHOMA**

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “Agricultural Risk Re-
3 view Act of 2025”.

**4 SEC. 2. INCLUSION OF THE SECRETARY OF AGRICULTURE
5 ON THE COMMITTEE ON FOREIGN INVEST-
6 MENT IN THE UNITED STATES.**

7 Section 721(k) of the Defense Production Act of
8 1950 (50 U.S.C. 4565(k)) is amended by adding at the
9 end the following:

10 “(8) INCLUSION OF THE SECRETARY OF AGRICULTURE.—The Secretary of Agriculture shall be a
11 member of the Committee with respect to a covered
12 transaction that involves—

14 “(A) agricultural land;

15 “(B) agriculture biotechnology; or

16 “(C) the agriculture industry, including ag-
17 ricultural transportation, storage, and proc-
18 essing.”.

1 **SEC. 3. CONSIDERATION OF CERTAIN AGRICULTURAL**
2 **LAND TRANSACTIONS.**

3 Section 721(b)(1) of the Defense Production Act of
4 1950 (50 U.S.C. 4565(b)(1)) is amended by adding at the
5 end the following:

6 “(I) CONSIDERATION OF CERTAIN AGRICULTURAL
7 LAND TRANSACTIONS.—

8 “(i) IN GENERAL.—After receiving notification from the Secretary of Agriculture
9 of a reportable agricultural land transaction,
10 the Committee shall determine—
11 action, the Committee shall determine—

12 “(I) whether the transaction is a
13 covered transaction; and

14 “(II) if the Committee determines that the transaction is a covered
15 transaction, whether the Committee should initiate a review pursuant
16 to subparagraph (D), or take another action authorized under this section,
17 with respect to the reportable agricultural land transaction.

18 “(ii) REPORTABLE AGRICULTURAL
19 LAND TRANSACTION.—In this subparagraph,
20 the term ‘reportable agricultural
21 land transaction’ means a transaction—

1 “(I) that the Secretary of Agri-
2 culture has reason to believe is a cov-
3 ered transaction, based on information
4 from or in cooperation with the intel-
5 ligence community;

6 “(II) that involves the acquisition
7 of an interest in agricultural land by
8 a foreign person of the People’s Re-
9 public of China, the Democratic Peo-
10 ple’s Republic of Korea, the Russian
11 Federation, or the Islamic Republic of
12 Iran; and

13 “(III) with respect to which a
14 person is required to submit a report
15 to the Secretary of Agriculture under
16 section 2(a) of the Agricultural For-
17 eign Investment Disclosure Act of
18 1978.

19 “(iii) SUNSET.—The requirements
20 under this subparagraph shall terminate,
21 with respect to a foreign person of the re-
22 spective foreign country, on the date that
23 the People’s Republic of China, the Demo-
24 cratic People’s Republic of Korea, the Rus-
25 sian Federation, or the Islamic Republic of

1 Iran, as the case may be, is removed from
2 the list of foreign adversaries in section
3 791.4 of title 15, Code of Federal Regula-
4 tions.”.
