

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 5396
OFFERED BY MS. PRESSLEY OF MASSACHUSETTS**

Add at the end the following:

1 **SEC. ____ . BETTER LABOR STATISTICS; MODERNIZING DU-**
2 **TIES AND TERMS RELATING TO THE BUREAU**
3 **OF LABOR STATISTICS.**

4 (a) **ADDITIONAL DUTIES.—**

5 (1) **LABOR STATISTICS.—**Section 4 of the Act
6 of March 4, 1913, titled “An Act to create a Depart-
7 ment of Labor” (29 U.S.C. 2; Chap. 141), is amend-
8 ed—

9 (A) in the first sentence, by striking “Sec-
10 retary of Labor may collate” and inserting
11 “Secretary of Labor shall collate”; and

12 (B) in the third sentence, by striking
13 “Such statistics shall be reported” and insert-
14 ing “Such statistics shall be publicly reported,
15 in accordance with the first section of Public
16 Law 94–311, online by the first Friday of each
17 month, including”.

18 (2) **DEMOGRAPHICS.—**The first section of Pub-
19 lic Law 94–311 (29 U.S.C. 8; 90 Stat. 688) fol-

1 lowing the resolving clause is amended by striking
2 “unemployment data” and all that follows and in-
3 serting “unemployment data relating to individual
4 demographics. In each labor statistics report re-
5 quired by section 4 of the Act of March 4, 1913, en-
6 titled ‘An Act to create a Department of Labor’ (29
7 U.S.C. 2; Chap. 141), the Secretary of Labor shall
8 include, at a minimum, data disaggregated by the
9 demographic categories of geography, race, ethnicity,
10 and gender.”.

11 (b) MODERNIZING TERMS.—Section 4 of the Act of
12 March 4, 1913, titled “An Act to create a Department
13 of Labor” (29 U.S.C. 2; Chap. 141), as amended by sub-
14 section (a), is further amended—

15 (1) in the first sentence—

16 (A) by striking “report at least once each
17 year, or oftener” and inserting “publicly report,
18 in accordance with the first section of Public
19 Law 94–311, at least once each year, or more
20 frequently”;

21 (B) by striking “provided for his depart-
22 ment” and inserting “provided for the Depart-
23 ment of Labor”; and

1 (C) by striking “such manner as to him”
2 and inserting “such manner as the Secretary”;
3 and

4 (2) in the last sentence, by striking “such man-
5 ner as he may deem satisfactory” and inserting
6 “such manner as the Secretary may deem satisfac-
7 tory”.

8 (c) HEADING.—The Law Revision Counsel is directed
9 to, where the first section of Public Law 94–311 (29
10 U.S.C. 8; 90 Stat. 688), as amended by subsection (a)(2),
11 is displayed in the United States Code, designate the head-
12 ing of such section as “Unemployment data relating to
13 individual demographics”.
