NAHT received a subcontract from Equal Justice Works (EJW), a nonprofit legal assistance organization, for training services for a national VISTA Volunteer program in HUD multifamily housing, administered by EJW as Intermediary for the Corporation for National and Community Service (CNCS), funded by HUD through an Interagency Agreement between HUD and CNCS. NAHT received \$62,826 in 2017; \$56,235 in 2018; and \$17,091 in 2019. The subcontract ended on September 28, 2019.
