The Committee will not alter the content of your submission but reserves the right to format it according to guidelines. Any materials submitted for the printed record and any written comments in response to a request for written comments must conform to the guidelines listed below. Any submission not in compliance with these guidelines will not be printed but will be maintained in the Committee files for review and use by the Committee.

All submissions and supplementary materials must be submitted in a single document via email, provided in Word format and must not exceed a total of 10 pages. Please indicate the date of the markup and the bills being considered as the subject line in your submission. Submitters are advised that the Committee relies on electronic submissions for printing the official record.

All submissions must include a list of all clients, persons and/or organizations on whose behalf the individual or organization is submitting. The name, company, address, telephone, and fax numbers of each individual or organization must be included in the body of the email. Please exclude any personal identifiable information in the attached submission.

Failure to follow the formatting requirements may result in the exclusion of a submission. All submissions for the record are final.
