

Markup Action Summary

November 8, 2023

The Chair called up the following measures separately:

- I. <u>H.R. 5933</u> (Rep. Steel) To amend the Higher Education Act of 1965 to require additional information in disclosures of foreign gifts and contracts from foreign sources, restrict contracts with certain foreign entities and foreign countries of concern, require certain staff and faculty to report foreign gifts and contracts, and require disclosure of certain foreign investments within endowments.
 - i. Rep. Steel (R-CA) offered an amendment in the nature of a substitute to H.R. 5933 designated <u>STEEL 055</u>.
 - The amendment in the nature of a substitute passed by voice vote.
 - a) Rep. Manning (D-NC) offered an amendment to the amendment in the nature of a substitute to H.R. 5933 designated <u>MANNIN_036</u>.
 - The amendment failed by a voice vote, and a recorded vote was subsequently requested by Rep. Manning. The amendment failed by a <u>roll call vote</u> of 11 yays and 22 nays.
 - b) Rep. Thompson (R-PA) offered an amendment to the amendment in the nature of a substitute to H.R. 5933 designated <u>THOMPA_052</u>.
 - The amendment passed by a voice vote.
 - c) Ranking Member Scott (D-VA) offered an amendment to the amendment in the nature of a substitute to H.R. 5933 designated <u>SCOTVA_022</u>.
 - The amendment failed by a voice vote, and a recorded vote was subsequently requested by Ranking Member Scott. The amendment failed by a <u>roll call vote</u> of 14 yays and 24 nays.
 - d) Rep. Moran (R-TX) offered an amendment to the amendment in the nature of a substitute to H.R. 5933 designated <u>MORATX 037</u>.
 - The amendment passed by a voice vote.

- e) Ranking Member Scott offered an amendment to the amendment in the nature of a substitute to H.R. 5933 designated <u>THRESHOLD 01</u>.
 - The amendment failed by a voice vote, and a recorded vote was subsequently requested by Ranking Member Scott. The amendment failed by a <u>roll call vote</u> of 14 yays and 24 nays.
- f) Ranking Member Scott offered the Democrat substitute to the amendment in the nature of a substitute to H.R. 5933 designated <u>DSUB_01</u>.
 - The amendment failed by a voice vote, and a recorded vote was subsequently requested by Ranking Member Scott. The amendment failed by a <u>roll call vote</u> of 14 yays and 24 nays.
- ii. H.R. 5933 was ordered favorably reported to the House as amended, by a <u>roll call</u> <u>vote</u> of 27 yays and 11 nays.
