

## Markup Action Summary September 17, 2025

## The Chair called up the following measures separately:

- 1. <u>H.R. 1723</u> (Rep. Moolenaar) A bill to clarify the rights of Indians and Indian Tribes on Indian lands under the National Labor Relations Act.
  - i. Rep. Messmer (R-IN) offered an amendment in the nature of a substitute to H.R. 1723, designated <u>HR1723 ANS.</u>
    - The amendment in the nature of a substitute passed by voice vote.
  - ii. A recorded vote on the motion to report H.R. 1723 as amended was requested. H.R. 1723 was ordered favorably reported to the House as amended, by a <u>recorded vote</u> of 19 yeas and 16 nays.
- 2. <u>H.R. 2958 (Rep. Rulli)</u> A bill to amend the Employee Retirement Income Security Act of 1974 to require that the Employee Benefit Security Administration submit an annual report to Congress on adverse interest agreements, and for other purposes.
  - i. Rep. Rulli (R- OH) offered an amendment in the nature of a substitute to H.R. 2958, designated <u>HR2958 ANS.</u>
    - The amendment in the nature of a substitute passed by voice vote.
  - ii. A recorded vote on the motion to report H.R. 2958 as amended was requested. H.R. 2958 was ordered favorably reported to the House as amended, by a <u>recorded vote</u> of 19 yeas and 16 nays.

- **3.** <u>H.R. 2844 (Rep. Harshbarger)</u> A bill to authorize the Department of Labor's voluntary protection program.
  - i. Rep. Mackenzie (R-PA) offered an amendment in the nature of a substitute to H.R. 2844, designated <u>VPPA 01.</u>
    - The amendment in the nature of a substitute passed by voice vote.
  - ii. A recorded vote on the motion to report H.R. 2844 as amended was requested. H.R. 2844 was ordered favorably reported to the House as amended, by a <u>recorded vote</u> of 19 yeas and 16 nays.
- **4.** <u>H.R. 2869 (Rep. McClain)</u> A bill to amend the Employee Retirement Income Security Act of 1974 to require that the Employee Benefit Security Administration make an annual report to Congress on investigations.
  - i. Rep. McClain (R-MI) offered an amendment in the nature of a substitute to H.R. 2869, designated HR2869 ANS.
    - The amendment in the nature of a substitute passed by voice vote.
  - ii. A recorded vote on the motion to report H.R. 2869 as amended was requested. H.R. 2869 was ordered favorably reported to the House as amended, by a recorded vote of 19 yeas and 16 nays.
- 5. <u>H.R. 3495 (Rep. Kiley)</u> A bill to amend the Fair Labor Standards Act of 1938 to clarify the definition of employee as it relates to direct sellers and real estate agents, and for other purposes.
  - i. Rep. Walberg (R-MI) offered an amendment in the nature of a substitute to H.R. 3495, designated <u>HR3495 ANS.</u>
    - The amendment in the nature of a substitute passed by voice vote.
  - ii. A recorded vote on the motion to report H.R. 3495 as amended was requested. H.R. 3495 was ordered favorably reported to the House as amended, by a recorded vote of 19 yeas and 16 nays.
- 6. <u>H.R. 5169 (Rep. Allen)</u> A bill to amend the Employee Retirement Income Security Act of 1974 to provide a clear definition of adequate consideration for certain closely held stock, and for other purposes.
  - i. Rep. Allen (R-GA) offered an amendment in the nature of a substitute to H.R. 5169, designated HR5169 ANS.
    - The amendment in the nature of a substitute passed by voice vote.
  - ii. A recorded vote on the motion to report H.R. 5169 as amended was requested. H.R. 5169 was ordered favorably reported to the House as amended, by a recorded vote of 35 yeas and 0 nays.
