The Chair called up the following measures separately:

1. **H.R. 6392 (Rep. Harris)** A bill to amend the Higher Education Act of 1965 to recognize students who have complete secondary school education in a home school setting as high school graduates, and for other purposes.
 - i. Rep. Harris (R-NC) offered an amendment in the nature of a substitute to H.R. 6392, designated [HR6392_ANS](#).
 - The amendment in the nature of a substitute passed by voice vote.
 - b. Rep. Scott (D-VA) offered an amendment to the amendment in the nature of a substitute to H.R. 6392, designated [AMD_01](#). The amendment passed by voice vote.
 - ii. A recorded vote on the motion to report H.R. 6392 as amended was requested. H.R. 6392 was ordered favorably reported to the House as amended, by a [recorded vote](#) of 33 yeas and 0 nays.
2. **H.R. 6472 (Del. Moylan)** A bill to amend the Higher Education Act of 1965 to provide for in-state tuition rates for certain residents of Guam, the Commonwealth of the Northern Mariana Islands, American Samoa, and the United States Virgin Islands, and for other purposes.
 - i. Del. Moylan (R-GU) offered an amendment in the nature of a substitute to H.R. 6472, designated [HR6472_ANS](#).
 - The amendment in the nature of a substitute passed by voice vote.
 - a. Rep. Adams (D-NC) offered an amendment to the amendment in the nature of a substitute to H.R. 6472, designated [ADAMNC_558](#). The amendment

failed by voice vote and a recorded vote was subsequently requested. The amendment failed by a [recorded vote](#) of 14 yeas and 19 nays.

- ii. A recorded vote was on the motion to report H.R. 6472 as amended was requested. H.R. 6472 was ordered favorably reported to the House as amended, by a [recorded vote](#) of 32 yeas and 1 nay.

3. **H.R. 6498 (Rep. Guthrie)** A bill to amend the Higher Education Act of 1965 to increase transparency in college tuition for consumers, and for other purposes.

- i. Rep. Onder (R-MO) offered an amendment in the nature of a substitute to H.R. 6498, designated [HR6498_ANS](#).
 - The amendment in the nature of a substitute passed by voice vote.
- a. Rep. Takano (D-CA) offered an amendment to the amendment in the nature of a substitute to H.R. 6498, designated [TAKANO_030](#). The amendment failed by voice vote and a recorded vote was subsequently requested. The amendment failed by a [recorded vote](#) of 14 yeas and 19 nays.
- b. Rep. Adams (D-NC) offered an amendment to the amendment in the nature of a substitute to H.R. 6498, designated [ADAMNC_560](#). The amendment was withdrawn.
- c. Rep. Adams (D-NC) offered an amendment to the amendment in the nature of a substitute to H.R. 6498, designated [ADAMNC_561](#). The amendment passed by a voice vote.

4. **H.R. 6502 (Rep. McClain)** A bill to amend the Higher Education Act of 1965 to require the Secretary of Education to develop requirements for institutions of higher education on formatting financial aid offer forms, and for other purposes.
