

AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 9605
OFFERED BY MR. GROTHMAN OF WISCONSIN

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “Less Bureaucracy,
3 Better Foreign Medical Accreditation Act”.

4 SEC. 2. TRANSFER OF DEPARTMENT OF EDUCATION FUNC-
5 TIONS RELATING TO THE NATIONAL COM-
6 MITTEE ON FOREIGN MEDICAL EDUCATION
7 AND ACCREDITATION.

8 There are transferred to the Secretary of Health and
9 Human Services (acting through the head of an Office of
10 the Department of Health and Human Services that is
11 in effect on the day before the date of enactment of this
12 Act) all of the functions which the Secretary of Education
13 exercised before the effective date of this Act (including
14 all related functions of any officer or employee of the De-
15 partment of Education) with respect to the advisory panel
16 established under section 102(a)(2)(B) of the Higher Edu-
17 cation Act of 1965 (20 U.S.C. 1002(a)(2)(B)) (referred

1 to as the “National Committee on Foreign Medical Edu-
2 cation and Accreditation”).

3 **SEC. 3. EXERCISE OF AUTHORITIES.**

4 Except as otherwise provided by law, the Secretary
5 of Health and Human Services may, for purposes of per-
6 forming a function transferred under this Act, exercise all
7 authorities under any other provision of law that were
8 available with respect to the performance of that function
9 to the Secretary of Education immediately before the ef-
10 fective date of the transfer of the function under this Act.

11 **SEC. 4. TRANSFER AND ALLOCATIONS OF APPROPRIA-**
12 **TIONS AND PERSONNEL.**

13 Except as otherwise provided in this Act, the per-
14 sonnel employed in connection with, and the assets, liabil-
15 ities, contracts, property, records, and unexpended bal-
16 ances of appropriations, authorizations, allocations, and
17 other funds employed, used, held, arising from, available
18 to, or to be made available in connection with the func-
19 tions transferred under this Act, subject to section 1531
20 of title 31, United States Code, shall be transferred to the
21 Secretary of Health and Human Services. Unexpended
22 funds transferred pursuant to this section shall be used
23 only for the purposes for which the funds were originally
24 authorized and appropriated.

1 **SEC. 5. AUTHORITY OF DIRECTOR OF THE OFFICE OF MAN-**
2 **AGEMENT AND BUDGET WITH RESPECT TO**
3 **FUNCTIONS TRANSFERRED.**

4 (a) PERSONNEL DETERMINATIONS.—The Director of
5 the Office of Management and Budget shall ensure that
6 this Act does not result in a net increase in full-time equiv-
7 alent employees at the Federal agencies impacted by this
8 Act, based on the number of such employees at such agen-
9 cies on the date of enactment of this Act.

10 (b) FUNCTION DETERMINATIONS.—If necessary, the
11 Director of the Office of Management and Budget shall
12 make any determination of the functions that are trans-
13 ferred under this Act.

14 (c) INCIDENTAL TRANSFERS.—The Director of the
15 Office of Management and Budget, at such time or times
16 as the Director shall provide, may make such determina-
17 tions as may be necessary with regard to the functions
18 transferred by this Act, and to make such additional inci-
19 dental dispositions of personnel, assets, liabilities, grants,
20 contracts, property, records, and unexpended balances of
21 appropriations, authorizations, allocations, and other
22 funds held, used, arising from, available to, or to be made
23 available in connection with such functions, as may be nec-
24 essary to carry out the provisions of this Act. The Director
25 shall provide for the termination of the affairs of all enti-
26 ties terminated by this Act and for such further measures

1 and dispositions as may be necessary to effectuate the pur-
2 poses of this Act.

3 (d) CERTIFICATION OF COMPLIANCE.—On the effec-
4 tive date of this Act, the Director of the Office of Manage-
5 ment and Budget shall certify compliance with this Act,
6 including the requirement under subsection (a), to the
7 Committee on Education and Workforce of the House of
8 Representatives and the Committee on Health, Education,
9 Labor, and Pensions of the Senate.

10 **SEC. 6. DELEGATION AND ASSIGNMENT.**

11 Except as otherwise expressly prohibited by law or
12 otherwise provided in this Act, the Secretary of Health
13 and Human Services may delegate any of the functions
14 so transferred to such officers and employees of the De-
15 partment of Health and Human Services as the Secretary
16 may designate, and may authorize successive redelegations
17 of such functions as may be necessary or appropriate. No
18 delegation of functions under this section or under any
19 other provision of this Act shall relieve the Secretary of
20 Health and Human Services of responsibility for the ad-
21 ministration of the function.

22 **SEC. 7. REFERENCES.**

23 With regard to functions transferred under section 2,
24 a reference in any other Federal law, Executive order,

1 rule, regulation, or delegation of authority, or any docu-
2 ment of or relating to—

3 (1) the Secretary of Education shall be deemed
4 to refer to the Secretary of Health and Human
5 Services; and

6 (2) the Department of Education shall be
7 deemed to refer to the Department of Health and
8 Human Services.

9 **SEC. 8. SAVINGS PROVISIONS.**

10 (a) **LEGAL DOCUMENTS.**—All orders, determinations,
11 rules, regulations, permits, grants, loans, contracts, agree-
12 ments, certificates, licenses, and privileges—

13 (1) that have been issued, made, granted, or al-
14 lowed to become effective by the President, any Fed-
15 eral agency or official thereof, or by a court of com-
16 petent jurisdiction, in the performance of any func-
17 tion that is transferred by this Act, and

18 (2) that are in effect on the effective date of
19 such transfer (or become effective after such date
20 pursuant to their terms as in effect on such effective
21 date),

22 shall continue in effect according to their terms until
23 modified, terminated, superseded, set aside, or revoked in
24 accordance with law by the President, the Secretary of

1 Health and Human Services, any other authorized official,
2 a court of competent jurisdiction, or operation of law.

3 (b) PROCEEDINGS.—This Act shall not affect any
4 proceedings or any application for any benefits, service,
5 license, permit, certificate, or financial assistance pending
6 on the date of the enactment of this Act before the De-
7 partment of Education (with respect to functions trans-
8 ferred by this Act). Such proceedings and applications
9 shall continue, orders shall be issued in such proceedings,
10 appeals shall be taken therefrom, and payments shall be
11 made pursuant to such orders, as if this Act had not been
12 enacted, and orders issued in any such proceeding shall
13 continue in effect until modified, terminated, superseded,
14 or revoked by a duly authorized official, by a court of com-
15 petent jurisdiction, or by operation of law. Nothing in this
16 subsection shall be considered to prohibit the discontinu-
17 ance or modification of any such proceeding under the
18 same terms and conditions and to the same extent that
19 such proceeding could have been discontinued or modified
20 if this Act had not been enacted.

21 (c) SUITS.—Except as provided in subsection (e)—

22 (1) this Act shall not affect suits commenced
23 before the effective date of this Act; and

24 (2) in all such suits, proceeding shall be had,
25 appeals taken, and judgments rendered in the same

1 manner and with the same effect as if this Act had
2 not been enacted.

3 (d) NONABATEMENT OF ACTIONS.—No suit, action,
4 or other proceeding commenced by or against the Depart-
5 ment of Education (with respect to the functions trans-
6 ferred by this Act), or by or against any individual in the
7 official capacity of such individual as an officer or em-
8 ployee of the Department of Education (with regard to
9 functions transferred by this Act), shall abate by reason
10 of the enactment of this Act.

11 (e) CONTINUANCE OF SUITS.—If, before the date on
12 which a transfer of a function under this Act takes effect,
13 the Secretary of Education or any officer or employee of
14 the Department of Education in the official capacity as
15 such an officer or employee is party to a suit relating to
16 the function, then such suit shall be continued and the
17 Secretary of Health and Human Services, or other appro-
18 priate official of the Department of Health and Human
19 Services, shall be substituted or added as a party.

20 (f) ADMINISTRATIVE PROCEDURE AND JUDICIAL RE-
21 VIEW.—Except as otherwise provided by this Act, any
22 statutory requirements relating to notice, hearings, action
23 upon the record, or administrative or judicial review that
24 apply to any function transferred by this Act shall apply
25 to the exercise of such function by the Secretary of Health

1 and Human Services, or other officers of the Department
2 of Health and Human Services to which such function is
3 transferred by this Act.

4 **SEC. 9. TRANSITION.**

5 Beginning on the date of enactment of this Act, the
6 Secretary of Health and Human Services is authorized to
7 use, for such period of time as may reasonably be needed
8 to facilitate the orderly implementation of this Act—

9 (1) the services of officers, employees, and other
10 personnel of the Department of Education with re-
11 gard to functions transferred under this Act;

12 (2) assets of the Department of Education with
13 regard to such functions; and

14 (3) funds appropriated to such functions.

15 **SEC. 10. DEFINITION OF FUNCTION.**

16 For purposes of this Act, the term “function” in-
17 cludes any duty, obligation, power, authority, responsi-
18 bility, right, privilege, activity, or program.

19 **SEC. 11. EFFECTIVE DATE.**

20 (a) IN GENERAL.—Except as provided in section 9,
21 this Act shall take effect 6 months after the date of enact-
22 ment of this Act.

23 (b) EARLY IMPLEMENTATION.—Notwithstanding
24 subsection (a), transfers of functions under section 2 or
25 any other provision of this Act (other than section 9) may

- 1 be carried out beginning on the date of enactment of this
- 2 Act but not later than the effective date of this Act.
