Strada Education Foundation has not sought or received any federal grants or contracts. However, over the last three years, one of Strada's wholly-owned charitable subsidiaries received three direct federal grants for workforce-related projects ((i) Department of Agriculture SNAP Employment and Training National Partnership Grant (\$1.4M); (ii) Department of Labor Advancing Delta Talent Grant (\$1.4M); and (iii) Department of Education Connected Pathways Program Grant (\$4.9M)) and was a subrecipient of \$240,000 under the Department of Labor Digital Workforce Apprenticeship Partnership Grant. All such grants were received at the subsidiary level and represent a minimal portion (i.e., less than -5%) of Strada's overall aggregated revenue and activities. Strada's subsidiaries also provide educational and workforce-related services to other organizations, including some organizations that receive federal funding.
