Dear Chairman Bean and Ranking Member Bonamici,

Teaching our youngest learners to hear others' opinions with kind respect is a fundamental call to action in our public schools and in service to our democracy.

As you prepare to interview Ms. Enikia Ford Morthel, Superintendent of the Berkeley Unified School District in California and a leader in one of our state's one thousand public school districts, I implore you to consider the questions and concerns that the world and national events bring into our schools. I urge you to consider the profound challenges that our education professionals face as they strive to balance students' needs to share opinions and concerns and the need to keep schools safe for all students.

Issues as complex as those connected to Israel and Gaza have deep historical roots often resulting in deeply divided opinions. Given that divisions and differing opinions exist between our most learned scholars, religious leaders, and political leaders, it makes sense that there are differences within the families that our Kindergarten – 12th-grade students' school districts serve.

Our education professionals are continuously working to balance the need for students to be heard, and to share their free speech rights while maintaining a safe environment for all to learn. Our educators work hard to support our students every day. Through their work, they can inspire the younger generation to become teachers and educators.

Local Voice -- Hearing and integrating the local values and voice of a school community is a bedrock principle in public education. State and Federal Departments of Education may set academic standards, and state legislatures may write laws that impact how we do our work, it is the local voice that shapes the culture of every district.

Please consider that Superintendent Ford-Morthel represents a district with a proud history of free speech and student activism. She is embracing and engaging her community, which is her legal and moral obligation.

Silence is Not Inaction -- You no doubt hear from constituents that "nothing is being done" to address concerns when in fact there are strict laws protect employees and student privacy rights; therefore, little if any detail can be offered to members of the public to articulate precisely what discipline may be levied on employees or students following a proper investigation. You can help this situation by clarifying that a lack of specific detail regarding discipline is not inaction, it is the law.

Support Our Work, Support Office for Civil Rights -- Our members recognize the critical role of OCR and we hope that you will support recommendations to fully fund this division within the US Department of Education so that they may continue their important work in a timely and responsive manner enabling a quicker resolution to the issues raised. This is in the best interest of the 6 million students served in California's public schools and by the school administrators whom I serve.

We are all throughout BUSD, and multi-generational. My mother was a kindergarten teacher for many years at both Sylvia Mendez and Malcolm X, and my sister was a librarian at BHS for many years, until last year when she went to be a librarian at

We are a family active in local (and global) politics with many decades of work in the Berkeley community.

We are a multi racial family, and we are Jewish. My brother in law is , who I think you know through his work as the co-chair of the .

I have been an educator in for 29 years and counting. I am in my 18th year as an administrator in **Example**.

My parents and I have attended the last 4 school board meetings (and many others off and on throughout the years.)

I want to say how disappointed I am in the recent lawsuits against the district. I do not believe those lawsuits represent a majority of the people in Berkeley. It has been powerful and uplifting to see the Jewish parents and community so visibly and overwhelmingly support the Liberated Ethnic Studies program. We seem to have a small minority of Jewish people making a lot of political noise. I am hopeful that you can see that.

I hope you will not be discouraged. I know your job is very challenging, and this situation only makes it more difficult. I want you to feel our support and know we are with you as you uphold and maintain progressive movement in Berkeley. Being bold with our support of students of color and all marginalized students is crucial in this moment (and all moments.) With everything going on around the country (firing of professors, closing down DEI departments, censorship of history curriculums, banning books, canceling valedictorian speeches, etc.) we must stay

steadfast in our anti racism work and in the work of telling the truth about hard history, as well as current events.

As Jewish people, we have diverse views, and as you can see from the recent school board meetings, many of us stand against zionism and colonialism, while maintaining our Jewish identity.

I just want you to know that you have a lot of support (as you are called to Washington DC.) We see you joining with the voices of the Justice Seekers who have been called to testify before such committees throughout history. It is not lost on us that they are calling primarily women of color as they target our work to tell the truth.

Many of us stay here in Berkeley because of the belief, the hope, and the promise of a special and different kind of community. My parents and their generation worked tirelessly (and are still working) to create a different kind of city. Berkeley isn't and never has been perfect (and maybe it was never as good as I thought it was as a child.) But we are here, still trying to build and maintain that special community. We are targeted by those outside our community (who link up with a few within our community) because they know we are progressive thinkers and movement shapers.

As an educator and community member, I just wanted to reach out and share my support for you, and my support for telling the truth to our children. We must tell and teach the truth even, maybe especially, when it is difficult and possibly uncomfortable (in a developmentally appropriate way!) The Berkeley teachers, as you know, are overwhelmingly fantastic. They know how to do this.
