06/26/14 Foreign Affairs Committee Markup Summary

The Chair called up the following measures for consideration by the Committee:

- 1. <u>H.R. 4347 (Royce)</u>, "Turkey Christian Churches Accountability Act." By unanimous consent, <u>Royce 117</u>, an amendment in the nature of a substitute to H.R. 4347 was considered base text for purposes of markup.
 - a. Connolly 124, an amendment in the nature of a substitute, was not agreed to by voice vote.

H.R. 4347, as amended, was ordered favorably reported to the House by unanimous consent.

 - d. <u>H.R. 4653 (Wolf)</u>, "To reauthorize the United States Commission on International Religious Freedom, and for other purposes."
 - i. <u>Smith 55</u>, an amendment in the nature of a substitute to H.R. 4653
 - 1. Meng 47, amending Smith 55
 - e. <u>H. Res. 435 (Deutch)</u>, "Calling on the government of Iran to fulfill their promises of assistance in this case of Robert Levinson, one of the longest held United States civilians in our Nation's history."
 - i. <u>Ros-Lehtinen 49</u>, an amendment in the nature of a substitute to H. Res. 435
 - f. <u>H. Res. 562 (Pitts)</u>, "Expressing the sense of the House of Representatives with respect to enhanced relations with the Republic of Moldova and support for Moldova's territorial integrity."
 - i. <u>Royce 123</u>, an amendment in the nature of a substitute to H. Res. 562
 - g. <u>H. Res. 588 (Peterson)</u>, "Concerning the suspension of exit permit issuance by the Government of the Democratic Republic of Congo for adopted Congolese children seeking to depart the country with their adoptive parents."
 - i. <u>Smith 57</u>, an amendment in the nature of a substitute to H. Res. 588
 - 1. <u>Royce 122</u>, amending Smith 57

The items *en bloc* were agreed to by voice vote, and the measures, as amended, were ordered favorably reported to the House by unanimous consent.
