- a. The Belfer Center has a contract with Foreign Policy Magazine to support "peace game" simulations. These Foreign Policy Magazine simulations were underwritten by the UAE Embassy in Washington DC. I gave two lectures and participated in several events the week of October 30, 2017 at the Emirates Diplomatic Academy about cybersecurity, which featured aspiring student-diplomats from around the world representing different countries, similar to Model United Nations. Expenses covered include roundtrip airfare (approx. \$6000 USD if booked directly), accommodations for four nights (approx. \$150 USD per night), airport transfers and meals (approx. \$400 USD). In addition, the Cyber Security Project received \$5,000 from the overall Belfer Center-Foreign Policy Magazine contract.
- b. Conferences often cover expenses for speakers, and organizations that host conferences abroad may receive money from foreign governments to support the conference and pay such expenses. I would be happy to provide the committee as much detail as possible at its request as to the conferences I attended since January 1, 2013, but to best of my recollection, my expenses were at least partially reimbursed or covered by money likely originating with a foreign government for attending a conference related to the subject of the hearing at the following:
  - i. World Government Summit, UAE (February 2016). Expenses covered include roundtrip airfare (approx. \$6000 USD if booked directly), accommodation for three nights (approx. \$250 USD per night), airport transfers and meals (approx. \$400 USD).
  - ii. CyCon, Cooperative Cyber Defence Centre of Excellence, Estonia/NATO (May/June 2016). Reimbursed airfare (approx. \$1500 USD). Expenses covered include accommodation for four nights (approx. \$150 USD per night), airport transfers and meals (approx. \$400 USD).
  - iii. Cybersecurity Workshop, Beijing, co-hosted by the Center for Strategic and International Studies and China Institutes of Contemporary International Relations (January 2017). Expenses covered include accommodation for two nights (approx. \$60 USD per night) and meals (approx. \$100 USD).
  - iv. Oxford Cyber Security Workshop/NATO (June 2017). Reimbursed airfare (approx. \$2000 USD). Expenses covered include accommodation for two nights (approx. \$150 USD per night), and meals (approx. \$100).
