2	LEARNING.
3	(a) Creating an Office of Strategic Planning
4	AND LEARNING.—
5	(1) IN GENERAL.—There is established an of-
6	fice within the Office of the Secretary to be known
7	as the "Office of Strategic Planning and Learning",
8	which shall be headed by a Director appointed by
9	the President by and with the advice and consent of
10	the Senate. To the extent the Secretary determines
11	it appropriate to also designate the Office of Policy
12	(as so designated pursuant to section 124) as, or
13	otherwise merge such Office with, the Office of Stra-
14	tegic Planning and Learning, the Director of such
15	merged office shall also be appointed by the Presi-

13	(D) Support the Director of the Bureau of
14	Budget and Planning of the Department on re-
15	source allocation planning and the formulation
16	of budget requests related to the NDDS, in-
17	cluding through input and participation in the
18	strategic plan process required by section 306
19	of title 5, United States Code.
20	(E) Coordinate strategic and policy-level
21	monitoring, evaluation, and learning by the De-
22	partment, including with respect to the imple-
23	mentation of the NDDS.
24	(b) Plan for Organizational Structure.—

1	(1) In general.—Not later than 180 days
2	after the date of enactment of this Act, the Sec-

23	ignate an existing office or establish a new

5	ganizational chart.
6	(2) Consultation.—Not later than 90 days
7	after the date of the enactment of this Act, the Sec-
8	retary shall consult with the appropriate congres-

10	plan required in paragraph (1).
