11	SEC2. ESTABLISHMENT OF UKRAINIAN REGIONAL SOC

13	(a) Establishment.—Not later than 180 days after
14	the date of enactment of this Act, the Secretary shall es-
15	tablish a program to support regional Security Operations
16	Centers and Computer Security Incident Response Teams
17	in Ukraine for the purposes of—
18	(1) providing more immediate response capabili-
19	ties and facilitating better national and local collabo-
20	ration;
21	(2) enabling faster mitigation of potentially dev-

- 1 (b) Selection of Regions.—The Secretary shall
