## 1 SEC. . AMERICA FIRST OPPORTUNITY FUND.

- 2 (a) Establishment.—There is established in the
- 3 Treasury of the United States a fund, to be known as the
- 4 "America First Opportunity Fund", (in this section re-
- 5 ferred to as the "Fund"), from which the Secretary of
- 6 State is authorized, subject to the requirements under
