21	TEES.—The term "appropriate congressional com-
22	mittees" means—
23	(A) the Committee on Appropriations and
24	the Committee on Foreign Affairs of the House
25	of Representatives; and

1	(B) the Committee on Appropriations and
2	the Committee on Foreign Relations of the Sen-
3	ate.
4	(2) GAZA HUMANITARIAN FOUNDATION.—The
5	term "Gaza Humanitarian Foundation" means—
6	(A) the Gaza Humanitarian Foundation;
7	(B) any organization that is associated
8	with, affiliated with, or a successor to the Gaza
9	Humanitarian Foundation, including UG Solu-
10	tions and Safe Reach Solutions;
11	(C) the principal officers of the Gaza Hu-
12	manitarian Foundation; and
13	(D) any entities with which such principal
14	officers are primarily associated.
