At the appropriate place, insert the following:

1	SEC [1255] COMPREHENSIVE DATABASE OF UNITED
2	STATES GOVERNMENT CONTRIBUTIONS TO
3	INTERNATIONAL ORGANIZATIONS.
4	(a) Database Required.—Not later than 180 days
5	after the date of the enactment of this Act, the Secretary,
6	acting through the Assistant Secretary for International
7	Organization Affairs, shall establish a comprehensive, con-
8	tinuously updated database of all Federal funding obli-
9	gated by any Federal entity for expenditure to an inter-
10	national organization. Each such obligation, and any sub-
11	sequent expenditures pursuant to such obligation, shall be
12	reported in the database along with the following informa-
13	tion:
14	(1) The identity of the recipient.
15	(2) The Federal entity providing the funds,
16	specifying a Bureau or other organizational unit
17	within the entity if applicable.
18	(3) Whether the funding was voluntary or as-
19	sessed.

1	(4) The account from which the funds were ob-
2	ligated.
3	(5) The purpose and a description of the funds,
4	including whether the funds were assessed or vol-
5	untary contributions to the recipient, if applicable.
6	(6) The dollar amount obligated.
7	(b) Information.—The Secretary shall take such
8	steps as may be necessary to ensure, in order to maintain
9	and update the database required by subsection (a), that
10	each transaction between a Federal entity and an inter-
11	national organization is reported to the Secretary not later
12	than 30 days after the completion of the transaction.
13	(e) Access.—The database established pursuant to
14	subsection (a) shall be made accessible to any member of
15	Congress upon request.
16	(d) Report.—Not later than the first July 1 after
17	the date of the enactment of this Act, and annually there-
18	after for 3 years, the Secretary shall submit to the appro-
19	priate congressional committees a report on the extent and
20	disposition of all financial contributions made by the
21	United States during the preceding year to international
22	organizations in which the United States participates as
23	a member.
24	(e) Definitions.—In this section:

1	(1) Appropriate congressional commit-
2	TEES.—The term "appropriate congressional com-
3	mittees" means—
4	(A) the Committee on Foreign Affairs and
5	the Committee on Appropriations of the House
6	of Representatives; and
7	(B) the Committee on Foreign Relations
8	and the Committee on Appropriations of the
9	Senate.
10	(2) International organization.—The term
11	"international organization" means any public inter-
12	national organization to which the privileges, exemp-
13	tions, and immunities provided by the International
14	Organizations Immunities Act (22 U.S.C. 288 et
15	seq.) have been extended, whether by a provision of
16	law or through an Executive Order.
