## AMENDMENT TO H.R. 5300 OFFERED BY MR. MILLS OF FLORIDA

At the appropriate place, insert the following:

1	SEC ASSESSING UNITED NATIONS PEACEKEEPING OP-
2	ERATIONS.
3	(a) Report to Congress on Peacekeeping Oper-
4	ATIONS PROGRESS.—Not later than 30 days prior to the
5	mandate renewal of each United Nations peacekeeping op-
6	eration, the Assistant Secretary of International Organiza-
7	tions Affairs, in coordination with the United States Am-
8	bassador to the United Nations and the heads of relevant
9	regional bureaus, shall submit to the appropriate congres-
10	sional committees a report that includes—
11	(1) a list of actions undertaken by the peace-
12	keeping operation to fulfill its mandate as authorized
13	by the United Nations Security Council in the pre-
14	ceding year;
15	(2) an assessment of the effectiveness of the
16	peacekeeping operation, of progress the peacekeeping
17	operation has made in the preceding year towards
18	fulfilling its mandate, and of the operation's ability
19	to fulfill its mandate as authorized by the United
20	Nations Security Council: and

1	(3) an assessment of the relevance of the peace-
2	keeping operation to United States interests.
3	(b) Building International Support to Termi-
4	NATE PEACEKEEPING OPERATIONS FAILING TO MAKE
5	Progress.—Upon the submission of each report required
6	by subsection (a), the Assistant Secretary for Inter-
7	national Organization Affairs, in coordination with the
8	United States Ambassador to the United Nations, may
9	seek to build international support to terminate each
10	peacekeeping operation that is assessed as failing to make
11	progress toward fulfilling its mandate in the preceding
12	year.
13	(c) Withholding of Funding for Peacekeeping
14	OPERATIONS FAILING TO MAKE PROGRESS.—
15	(1) In general.—Should a mandate for a
16	United Nations peacekeeping operation be renewed
17	that is assessed, pursuant to subsection (a), to have
18	failed to make progress toward fulfilling its mandate
19	in the past 12 months, the Assistant Secretary for
20	International Organization Affairs may withhold
21	funding for that peacekeeping operation until the
22	next mandate renewal contingent upon the submis-
23	sion of report required in subsection (a).
24	(2) Notification to congress.—Not later
25	than 15 days after the date that the provision of

1	funding for a peacekeeping operation pauses or re-
2	sumes pursuant to paragraph (1), the Assistant Sec-
3	retary shall submit to the appropriate congressional
4	committees—
5	(A) a notification of such pause or resump-
6	tion; and
7	(B) a justification for such pause or re-
8	sumption.
