1	SEC ASSESSMENT, MONITORING, AND EVALUATION
2	OF FOREIGN ASSISTANCE PROGRAMS AND
3	ACTIVITIES.
4	(a) Program Required.—The Secretary shall
5	maintain a program of assessment, monitoring, and eval-
6	uation in support of the foreign assistance programs and
7	activities of the Department.
8	(b) Program Elements and Requirements.—
9	(1) Elements.—The program under sub-
10	section (a) shall provide for the following:
11	(A) Initial assessments of partner capa-
12	bility requirements, potential programmatic
13	risks, baseline information, and indicators of ef-
14	ficacy for purposes of planning, monitoring, and
15	evaluation of foreign assistance programs and
16	activities of the Department.
17	(B) Monitoring of implementation of such
18	programs and activities in order to measure
19	progress in execution and, to the extent pos-
20	sible achievement of desired outcomes

1	(C) Evaluation of the efficiency and effec-
2	tiveness of such programs and activities in
3	achieving desired outcomes.
4	(D) Identification of lessons learned in car-
5	rying out such programs and activities, and de-
6	velopment of recommendation for improving fu-
7	ture foreign assistance programs and activities
8	of the Department.
9	(2) Best practices.—The program shall be
10	conducted in accordance with international best
11	practices, interagency standards, and, as applicable,
12	in accordance with the best practices described with
13	respect to the assessment, monitoring, and evalua-
14	tion program required by section 383 of title 10,
15	United States Code.
16	(c) AVAILABILITY OF FUNDS.—
17	(1) In general.—Amounts authorized under
18	this title to be appropriated for the Office of Foreign
19	Assistance Oversight, and other amounts made
20	available to the Department to carry out foreign as-
21	sistance programs and activities of the Department,
22	are authorized to be made available to carry out the
23	program required by subsection (a).
24	(2) Budget Justification.—Funds described
25	in paragraph (1) and allocated to carry out the pro-

1	gram required by subsection (a) for a fiscal year
2	shall be identified, with appropriate justification, in
3	the budget materials submitted to Congress in sup-
4	port of the President's annual budget request (sub-
5	mitted to Congress pursuant to section 1105 of title
6	31, United States Code) by the Secretary for such
7	fiscal year.
8	(d) Reports.—
9	(1) Reports to congress.—The Secretary
10	shall submit to the appropriate congressional com-
11	mittees each year a report on the program under
12	subsection (a) during the previous year. Each report
13	shall include, for the year covered by such report,
14	the following:
15	(A) A description of the activities under
16	the program.
17	(B) An evaluation of the lessons learned
18	and best practices identified through activities
19	under the program.
20	(2) Information for the public on eval-
21	UATIONS.—The Secretary shall publish on a publicly
22	available website of the Department a summary of
23	each evaluation conducted pursuant to subsection
24	(b)(1)(C). In publishing such summary, the Sec-
25	retary may redact or omit any information that the

1	Secretary determines should not be disclosed to the
2	public in order to protect the interest of the United
3	States or the foreign country or countries covered by
4	such evaluation.
5	(3) Appropriate congressional commit-
6	TEES DEFINED.—In this section, the term "appro-
7	priate congressional committees" means—
8	(A) the Committee on Foreign Affairs and
9	the Committee on Appropriations of the House
10	of Representatives; and
11	(B) the Committee on Foreign Relations
12	and the Committee on Appropriations of the
13	Senate.
