

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 9087
OFFERED BY MR. CASTRO OF TEXAS**

At the appropriate place, insert the following:

1 **SEC. ____ . INTERNATIONAL NARCOTICS AND LAW ENFORCE-**
2 **MENT TRAINING.**

3 Section 708 of the Foreign Service Act of 1980 (22
4 U.S.C. 4028) is amended by adding at the end the fol-
5 lowing:

6 “(f) INTERNATIONAL NARCOTICS AND LAW EN-
7 FORCEMENT TRAINING.—

8 “(1) IN GENERAL.—The Secretary, in consulta-
9 tion with the Assistant Secretary for International
10 Narcotics and Law Enforcement Affairs and such
11 other officials as the Secretary considers appro-
12 priate, may establish training courses on—

13 “(A) international narcotics control, in-
14 cluding the mechanisms, legal authorities, and
15 programmatic requirements applicable to assist-
16 ance provided under International Narcotics
17 and Law Enforcement Affairs’s statutory au-
18 thorities relating to international narcotics con-
19 trol and law enforcement assistance;

1 “(B) international law enforcement co-
2 operation, including the use of bilateral and
3 multilateral legal assistance frameworks;

4 “(C) countering transnational organized
5 crime, money laundering, and other tools of il-
6 licit finance;

7 “(D) anti-corruption efforts, including
8 most effective methods of countering corruption
9 and promoting the rule-of-law abroad; and

10 “(E) human rights obligations applicable
11 to the administration of security and law en-
12 forcement assistance required by section 620M
13 of the Foreign Assistance Act of 1961 (22
14 U.S.C. 2378d).

15 “(2) REQUIRED TRAINING.— Any member of
16 the Service who is directly responsible for the admin-
17 istration, oversight, or management of assistance de-
18 scribed in paragraph (1)(A) should receive training
19 in the areas described in paragraph (1) prior to the
20 beginning of service in such assignment or, if receiv-
21 ing such training prior to the beginning of service is
22 not practicable, not later than one year after begin-
23 ning such assignment.

1 “(3) CONSULTATION.—In developing the cur-
2 riculum required under paragraph (1), the Secretary
3 shall consult with—

4 “(A) the Bureau of International Narcotics
5 and Law Enforcement Affairs;

6 “(B) the Bureau of Democracy, Human
7 Rights, and Labor;

8 “(C) the Office of the Legal Adviser; and

9 “(D) other relevant bureaus and offices of
10 the Department as the Secretary determines
11 appropriate.”.
