Sung-Yoon Lee is Kim Koo-Korea Foundation Professor of Korean Studies and Assistant Professor at The Fletcher School of Law and Diplomacy, Tufts University. He is also Faculty Associate at the Program on U.S.-Japan Relations, Weatherhead Center for International Affairs, Harvard University.

He is the author of *The Sister: The Extraordinary Story of Kim Yo Jong, North Korea's Most Powerful Woman* (London: MacMillan, 2022), to be released on January 19, 2023.

Dr. Lee's essays on the international politics of the Korean peninsula and Northeast Asia have been published multiple times in the *New York Times*, *Wall Street Journal*, *Washington Post*, *LA Times*, *Foreign Affairs*, *Foreign Policy*, *Christian Science Monitor*, *CNN.com*, etc. He is a regular contributor to *The Hill*.

He has also testified as an expert witness in behalf of the plaintiffs in the United States District Court for the District of Columbia in the *Warmbiers v. DPRK* case, in which the plaintiffs were awarded \$501 million, and in behalf of the defendant in the U.S. District Court for the Central District of California (LA) in the *USA v. Christopher P. Ahn* extradition hearing (pending).
