Dr. White currently serves as the Co-Executive Director of the Advocacy Foundation for Human Rights (AFHR) in Washington, DC.

Dr. White is a retired US Federal Law Enforcement Senior Executive, where he served as the Director of Investigations, Defense Criminal Investigative Service (DCIS), Office of Inspector General, US Department of Defense, Washington, DC, responsible for oversight of all DCIS criminal investigative and law enforcement operations worldwide.

Dr. White also served as a Senior Executive with the United Nations-backed Special Court for Sierra Leone, where he served as the Chief of Investigations responsible for directing all war crimes and criminal investigations for the Office of the Prosecutor concerning those bearing the greatest responsibility for the civil war in Sierra Leone.

Dr. White's efforts led to multiple indictments and convictions, including former Liberian President Charles Taylor, who was the first sitting Head of State indicted and convicted of war crimes, receiving a 50-year sentence.

Dr. White is also a partner in BW Global Group, LLC, Washington, DC, where he provides a wide variety of consulting services involving human rights violations, anti-corruption, and governmental affairs globally and engages various governments and legislatures seeking justice and accountability for their clients, including prosecutions, sanctions, and other remedies.

Dr. White is also the President of AW Associates, LLC, and provided consulting services, such as an Executive Mentor for the US State Department working with the Ministries of Interior and Justice in Afghanistan to establish anti-corruption, anti-terrorism, and anti-kidnapping programs.

Dr. White served as the Executive Director for the United Kingdom, DFID \$35 million government-wide anti-corruption Program in Uganda known as Strengthening Uganda's Anti-corruption Response (SUGAR), Kampala, Uganda. Dr. White developed a government-wide Anti-corruption Program Response coordinating criminal, civil, and administrative actions against those individuals and companies involved in bribery, fraud, and corruption.

Dr. White established worldwide Anti-corruptions & Anti-Fraud Programs for the US Agency for International Development (USAID).

Dr. White served on Active Duty and as a Reservist in the United States Air Force as a Special Agent for the Office of Special Investigations (OSI), conducting global investigations involving criminal, fraud, counterintelligence, counterespionage, anti-terrorism, and counterterrorism matters stationed in the United States and Europe.

Dr. White served as a Police Officer for the City of Moraine, Ohio conducting law enforcement duties and is a graduate of the Ohio Peace Officers Training Academy. Dr. White received the Moraine Police Valor Commendation for engaging and arresting an armed robbery suspect while exchanging gunfire.
