



James Prince is the co-founder (2000 to present) and president of the Democracy Council, a leading nonprofit organization dedicated to promoting democracy, good governance, rule of law and equal opportunity in emerging countries. His responsibilities include developing and implementing projects aimed at building the capacity of civil society, in countries, such as; Iran, Iraq, Palestinian Authority, and Syria. Jim draws upon over twenty years of international development and post-conflict reconstruction experience and is a leading expert on civil society in the Arab world.

Jim's experience in the Palestinian Authority (PA) started as a consultant to the Palestinian Monetary Authority in 1999 when he designed and led an investigation of the Palestinian Investment Bank. From 2000 to 2006, he managed a five year, multimillion dollar effort to build transparency and institutional development within the PA as a consultant reporting to the Minister of Finance and, later, Prime Minister. During this period, Jim led an investigation into internal PA governance, and examined over seventy outside enterprises owned or controlled by the PA. The effort included helping to design the Palestine Investment Fund and brought back over \$700 million into the Palestinian Treasury. He later authored many reports on economic development, trade and governance for the Minister of Finance and Palestine Investment Fund. Jim's work in the PA was covered in most major national and international media outlets, including a presentation at the World Economic Forum and a feature segment by CBS' 60 Minutes, and was the inspiration for a series of mystery novels set in West Bank/Gaza.

Jim served with international electoral and peacekeeping missions in Afghanistan, Cambodia, Iraq, Iran, Palestinian Authority, and South Africa. He was as a New Generation Fellow with the American Assembly and appointed by the Mayor of Los Angeles to the committee investigating corruption in the LA police department.

Prior to starting the Democracy Council, Jim was a Director with Pricewaterhouse Coopers' Financial Advisory Services, a senior professional staff member for the House Committee on Foreign Affairs, Subcommittee on Western Hemisphere, and worked in the Middle Eastern Studies department at the Council on Foreign Relations. He also managed a National Endowment for Democracy grant to Freedom House to establish a public policy institute at a university in northern Iraq. Jim was a foreign policy advisor (unpaid) for the Middle East during the first Clinton/Gore presidential campaign.
