From April 2018 to April 2021 I was employed by the Office of the Secretary of Defense under an Intergovernmental Personnel Act (IPA) arrangement with my employer at the time, the Foundation for the Defense of Democracies (FDD), a Washington-based 501(c)(3) research institute. During this time, FDD was reimbursed for the exact amount of the total cost associated with my employment, which totaled \$297,609.53 during my three years in OSD.

Though they did not involve me, my employer, The Washington Institute For Near East Policy, a 501(c)(3) research organization, had 3 Intergovernmental Personnel Act (IPA) Agreements since January 1, 2019 as follows:

1. IPA with the Department of Defense. The agreement enabled an employee of the organization to work in the Office of the Secretary of Defense, International Affairs – Middle East. The agreement ran from February 19, 2019 to January 21, 2020. Total contract revenue of \$56,355.68 was paid to the organization to reimburse their cost of the employee's salary and benefits.

2. IPA with the National Security Council. The agreement enabled an employee of the organization to work in the National Security Council as Director for the Levant. The agreement ran from May 13, 2019 to November 6, 2019. The agreement did not include any reimbursable expenses and no revenue was received by the organization.

The agreement enabled an employee of the organization to work in the office of the Special Envoy for Syria in the Department of State's Bureau of Near Eastern Affairs, Office of Levant an from January 6, 2020 to January 20, 2021. Total contract revenue of \$183,643.38 was paid to the organization to reimburse their cost of the employee's salary and benefits.
