I am not personally involved (or have been involved in any projects). However, I am not aware (or able to ascertain at such short notice) of any projects that colleagues at RUSI might be working on.

I have worked on projects for the UK government, the Canadian government, the European Aid Agency DEVCO, and the EU's Radicalisation Awareness Network looking at terrorism and extremism in the past 36 months. I have played a sub-contracting role, and consequently am only aware of my own compensation, which varied from an equivalent of around \$10,000 to \$40,000 (in Euros and Sterling). At short notice am not able to ascertain the total project amounts, nor am I able to ascertain what other colleagues at RUSI are doing.


