WITNESSES INSTRUCTIONS:

Required Materials: To satisfy the requirements of House and Committee rules, the following materials must be submitted no later than two (2) business days before the hearing, to avoid mandatory witness exclusion. (Please note that two business days before a Tuesday hearing means Friday of the preceding week.)

- Written Statement: Written testimony should be in final form, and electronic files should not include any hidden text or tracked changes that are not intended to be public. The text of the written statement shall be considered final and may not be revised by the witness after the hearing at which the witness appears. The first page of the written statement should display the following information:
 - o Name:
 - o Title and organizational affiliation;
 - o The name of the Committee (House Committee on Foreign Affairs);
 - o The date and title of the hearing at which the witness is testifying; and
 - o If applicable, the identity of any translator used to prepare the written statement, and any interpreter whom the witness intends to use at the hearing.
- Curriculum vitae or resume and a brief biography summarizing the curriculum vitae or resume
- Completed "Truth in Testimony" form
 - o For questions or information about this form, please contact the Hearing Coordinator.
- Any videos, photos, audio-visual matter, posters or other supporting materials that the witness intends to present or display.

Hearing Presentation: A witness shall limit oral testimony at the hearing to no more than five (5) minutes, briefly summarizing the written statement. The written statement may be longer and submitted for the record, up to eight (8) pages.

Questions for the Record: Additional questions submitted for the record may be sent to the witness after the hearing. If there are questions for the record, please email answers to the Hearing Coordinator within five (5) business days of receipt, so that the questions and answers may be included in the Committee print of the hearing.

Transcript Corrections: The witness will receive a stenographic transcript of the witness hearing remarks for review. The witness may submit technical, grammatical, and typographical corrections (substantive revision is not permitted) to the Hearing Coordinator, which is due within one (1) week of receipt.

Optional Materials: There is also an optional survey on witness diversity that the witness may submit here. This survey is provided by the Tri-Caucus Initiative to track the diversity of the witnesses who testify before Committees. If the witness is testifying virtually and would like to practice connecting to the platform, please email the Hearing Coordinator.

Dear Ambassador Tom:

I am writing to invite you to testify at a hearing, entitled "Update on COVID-19 in Africa," to be held before the House Foreign Affairs Subcommittee on Africa, Global Health, and Global Human Rights at 1:00 pm EST. on Wednesday, March 17, 2021, via Cisco WebEx.

The purpose of this hearing is to receive an update on the effects of COVID-19 in Africa including the long-term socio-economic impact the pandemic has caused on the continent. After the first COVID-19 case was recorded on February 14, 2020, the World Health Organization's modeling system predicted that 29 million to 44 million Africans could be infected in the first year of the pandemic, with a predicted 83,000 to 190,000 deaths. However, the African continent has defied the doomsday scenarios a year into the pandemic. Members will be interested to learn how African countries have collaborated with multilateral groups such as the African Union and African Centres for Disease Control, and with regional organizations and local partners to combat the spread of COVID-19 and to address the economic impacts of the pandemic. Members will also be interested to hear about any recommendations you may have for how the U.S. government can assist African led initiatives and strengthen support to international organizations.
