#### H.R. 5714 (Chaffetz), the Postal Service Reform Act of 2016

The bill was favorably reported to the House by a voice vote.

#### H.R. 2319 (Cummings), the Electronic Message Preservation Act of 2015

#### H.R. 4419 (Norton), the District of Columbia Judicial Financial Transparency Act

 Ms. Norton offered an amendment that would add sections that are in the Senate companion bill – authority for magistrate judges to serve in the probate division, allow courts to accept payments by credit card and check, increase the maximum amount in controversy for small claims court to \$10,000, and authorize judges to delegate their authority to approve reimbursement to court-appointed attorneys.
