## A BILL

To require the purchase of domestically made flags of the  
United States of America for use by the Federal Government.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “All-American Flag  
5 Act”.

1 **SEC. 2. REQUIREMENT FOR PURCHASE OF DOMESTICALLY**  
2 **MADE UNITED STATES FLAGS FOR USE BY**  
3 **FEDERAL GOVERNMENT.**

4 (a) **IN GENERAL.**—Only such flags of the United  
5 States of America, regardless of size, that are 100 percent  
6 manufactured in the United States, from articles, mate-  
7 rials, or supplies 100 percent of which are grown, pro-  
8 duced, or manufactured in the United States, may be ac-  
9 quired for use by the Federal Government.

10 (b) **AVAILABILITY EXCEPTION.**—Subsection (a) does  
11 not apply if articles, materials, or supplies of the class or  
12 kind to be used, or the articles, materials, or supplies from  
13 which they are manufactured, are not grown, produced,  
14 or manufactured in the United States in sufficient and  
15 reasonably available commercial quantities and are not of  
16 a satisfactory quality.

17 (c) **PRESIDENTIAL WAIVER.**—

18 (1) **IN GENERAL.**—The President may waive  
19 the requirement in subsection (a) if the President  
20 determines a waiver is necessary to comply with any  
21 trade agreement to which the United States is a  
22 party.

23 (2) **NOTICE OF WAIVER.**—Not later than 30  
24 days after granting a waiver under paragraph (1),  
25 the President shall publish a notice of the waiver in  
26 the Federal Register.

1 **SEC. 3. APPLICABILITY.**

2       Section 2 shall apply with respect to any contract en-  
3       tered into on or after 180 days after the date of the enact-  
4       ment of this Act.
