<u>H.R. 2623 (Meadows-NC), Lessening Regulatory Costs and Establishing a Federal Regulatory Budget Act</u> of 2017

- 2. Ms. Norton offered an amendment to the Meadows ANS that exempts regulations related to sexual harassment from the one-in-two-out process and reporting requirements in section 5. The amendment failed by a record vote of 15-20 (vote #1).

H.R. 4431 (Carter-GA), Correcting Miscalculations in Veterans' Pensions Act

1. Mr. Cummings offered an amendment that provides permissive authority to the Office of Personnel Management to pay interest assessed on federal government civilian pension deposits made by former Peace Corps and AmeriCorps members. The amendment was withdrawn.

The bill was ordered favorably reported to the House by voice vote.

H.R. 3655 (Smith-NJ), To designate the facility of the United States Postal Service located at 1300 Main Street in Belmar, New Jersey, as the "Dr. Walter S. McAfee Post Office Building";

H.R. 4042 (Soto-FL), To designate the facility of the United States Postal Service located at 1415 West Oak Street, in Kissimmee, Florida, as the "Borinqueneers Post Office Building";

H.R. 4285 (LoBiondo-NJ), To designate the facility of the United States Postal Service located at 123 Bridgeton Pike in Mullica Hill, New Jersey, as the "James C. 'Billy' Johnson Post Office Building"; and

H.R. 4301 (Norman-SC), To designate the facility of the United States Postal Service located at 201 Tom Hall Street in Fort Mill, South Carolina, as the "J. Elliott Williams Post Office Building."
