identifying each such action, including, to the extent prac-2 ticable— 3 "(1) a description of the action; 4 "(2) an indication of whether a response is re-5 quired, optional, or not required; 6 "(3) the deadline, if applicable; "(4) directions on how to complete the action; 7 8 and 9 "(5) the contact information for an individual 10 in the agency relating to the communication.". 11 (b) GUIDANCE.—Not later than 6 months after the 12 date of the enactment of this Act, the Director of the Of-13 fice of Management and Budget shall update the guidance issued pursuant to section (4)(d) of the Plain Writing Act 14 15 of 2010 (Public Law 111–274; 5 U.S.C. 301 note), as redesignated by subsection (a)(1), to include the require-16 17 ments of this Act. 18 SEC. 3.
