H.R. 1847 (Lieu), the Inspector General Protection Act

- 1. Mr. Cummings offered an Amendment in the Nature of a Substitute (ANS) which passed by voice vote.
- **2.** Mr. Gomez offered an amendment to the ANS that would have added a new section regarding vacancy of inspector general positions. He later **withdrew** his amendment.

H.R. 1847, as amended, was ordered favorably reported to the House by voice vote.

H.R. 1076 (Cummings), the Fair Chance Act

- **1.** Mr. Cummings offered an amendment in the nature of a substitute (ANS) which passed by voice vote.
- 2. Mrs. Miller offered an amendment to the ANS that would have exempted federal contractors from liability from provisions of the Act. The amendment failed by a recorded vote of 18-13.

YEAS: Jordan, Gosar, Foxx, Massie, Meadows, Hice, Grothman, Gibbs, Higgins, Roy, Miller, Armstrong, and Steube.

- **3.** Mr. Roy offered an amendment to the ANS which would have created new disciplinary standards for all Federal employees. The amendment was ruled non-germane by the Chairman.
 - a. Mr. Roy appealed the ruling of the Chairman.

b. Ms. Wasserman-Schultz moved to table the appeal of the ruling of the Chairman, which passed by a recorded vote of 17-14.

4. Mr. Roy offered an amendment to the ANS which would strike all provisions of the bill related to Federal contractors. The amendment failed by voice vote.

H.R. 1076, as amended, was ordered favorably reported to the House by voice vote.

H.R. 745 (Raskin), the Executive Branch Comprehensive Ethics Enforcement Act

- 1. Mr. Cummings offered an amendment in the nature of a substitute (ANS) which passed by voice vote.
- **2.** Mr. Steube offered an amendment to the ANS which would Authorize \$17,019,000 for OGE, which is less than President Trump requested for the FY2020 budget. The amendment failed by voice vote.
- **3.** Mr. Green offered an amendment to the ANS which referred Michael Dean Cohen to DOJ for a criminal investigation. The amendment was ruled non-germane by the Chairman.
 - a. Mr. Green appealed the ruling of the Chairman.
 - b. Mr. Raskin moved to table the appeal of the ruling of the Chairman, which passed by a recorded vote of 18-6.

4. Mr. Meadows offered an amendment to the ANS which adds "unprofessional political communication" to a list of reasons for cause for removal of the OGE Director. The amendment failed by a recorded vote of 14-17.

- **5.** Mr. Meadows offered another amendment to the ANS which would strike from the bill provisions providing certain authorities to the Director of OGE. The amendment failed by voice vote.
- **6.** Mr. Hice offered an amendment to the ANS which would strike the subpoena authority of the OGE Director, which failed by recorded vote 14-17.
