(a) HATCH ACT OFFICER APPLICABILITY.— 6

7 (1) IN GENERAL.—Section 410 of title 39, United States Code, is amended by adding at the 8 9 end the following new subsection:

- 14 "(1) The Postmaster General.
- 15 "(2) The Deputy Postmaster General.

16 "(3) Any individual holding a position in the 17 Postal Service to which such individual was ap-18 pointed by the President, by and with the advice and  $\mathbf{2}$

2	pointed under section 202.".
3	(2) Further restricted employees.—Sec-
4	tion 7323(b)(2)(B) of title 5, United States Code, is
5	amended—
6	(A) in clause (i)(XIV), by striking "or" at

8	(B) in clause (ii), by striking the period at
9	the end and inserting "; and"; and
10	(C) by adding at the end the following new
11	clause:
12	"(iii) a person holding a position described in
13	section 410(e) of title 39.".
14	(b) Political Activities of Board Members.—
15	Section 202 of title 39, United States Code, is amended—
16	(1) in subsection (c)—
17	(A) by striking "The Governors shall" and
18	inserting "(1) The Governors shall"; and
19	(B) by adding at the end the following new
20	paragraph:
21	"(2) The Governors may appoint as the Post-
22	master General only an individual who has not held
23	a political position at any time during the 4-year pe-
24	riod ending on the date on which such individual is
25	so appointed.";

4 "(2) files paperwork to be a candidate for elec5 tion for a Federal, State, or local elected office; or
6 "(3) is an officer, director, or employee of a
7 Federal, State, or local political party (as defined in
8 subsection (f)(2)(B)).".

9 (c) SEVERABILITY.—If any provision of this Act, an 10 amendment made by this Act, or the application of such 11 provision or amendment to any person or circumstance is 12 held to be unconstitutional, the remainder of this Act, the 13 amendments made by this Act, and the application of the 14 provisions of such to any person or circumstance shall not 15 be affected thereby.
