- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "GAO Audit Mandates
- 5 Revision Act of 2022".
- 6 SEC. 2. AUDITS MODIFIED.
- 7 (a) Export-import Bank Loan and Guarantee
- 8 Transactions.—Section 17(a) of the Export-Import

2	is amended by striking "and periodically (but not less fre-
3	quently than every 4 years) thereafter,".

20	diting standards as may be prescribed by the Comptroller
