### H. R. 4984 (Comer), THE “D.C. ROBERT F. KENNEDY MEMORIAL STADIUM CAMPUS REVITALIZATION ACT”

A bill “to amend the District of Columbia Stadium Act of 1957 to provide for the transfer of administrative jurisdiction over the Robert F. Kennedy Memorial Stadium Campus to the Administrator of General Services and the leasing of the Campus to the District of Columbia for purposes which include commercial and residential development, and for other purposes.”

1. Mr. Comer offered an amendment in the nature of a substitute (ANS). The amendment in the nature of a substitute passed by voice vote.
2. Mr. Perry offered an amendment to the ANS that would prohibit any public funds, including funds appropriated or otherwise made available by the Federal Government, from being used for such purposes. The amendment failed by a Roll Call vote of 13-24 (Vote #1).

**H. R. 5040 (Raskin), THE “CANNABIS USERS’ RESTORATION OF ELIGIBILITY (CURE) ACT”**

A bill “amend the Intelligence Reform and Terrorism Prevention Act of 2004 to limit the consideration or marihuana use when making a security clearance or employment suitability determination, and for other purposes.”

1. Mr. Comer offered an amendment in the nature of a substitute (ANS). The amendment in the nature of a substitute passed by voice vote.
2. Mr. Sessions offered an amendment to the ANS that would limit the issuing of security clearances and Federal employment for use of marihuana during three-year period preceding security clearance or employment application. The amendment failed by a Roll Call vote of 15-28 (Vote #3).
