## H.R. 6283 (Miller-Meeks), THE "DELINKING REVENUE FROM UNFAIR GOUGING (DRUG) ACT"

A bill "to improve services provided by pharmacy benefit managers."

- 1. Mr. Comer offered an amendment in the nature of a substitute (ANS) making certain clarifying edits. The amendment in the nature of a substitute passed by voice vote.
- 2. Mr. Raskin offered an amendment to the ANS which would create a new section to require health benefits plan/carriers/PBMs which offer FEHBP plans to submit a report every 6 months. The amendment was offered and withdrawn.
- **3.** Mr. Lynch offered an amendment to the ANS which would create a new section to require a PBM provide to OPM and the OPM IG full access to information relating to contracts. The amendment (Lynch #1) was offered and withdrawn.
- **4.** Mr. Krishnamoorthi offered an amendment to the ANS which would add a new subsection (e) to amend the contracting authority require OPM to publicly report the following info: aggregate amount of rebate received by PBMs, administrative fees PBMs receive from drug manufacturers, and rebates that weren't passed on to "such entities." The amendment passed by voice vote.
- 5. Ms. Crockett offered an amendment to the ANS which would condition the underlying bill's provisions on an OPM certification and require GAO to analyze and report to Congress within one year, on the following: pharmacy network inclusion, payer choice in pharmacy network design, the state of competition among PBMs, use of rebates and other fees by PBMs, and recommendations for legislative action. The amendment failed by a Roll Call vote of 20-22 (Vote #8)

# H.R. 7219 (McClain), THE "INFORMATION QUALITY ASSURANCE ACT (IQAA) OF 2024"

A bill "to ensure that Federal agencies rely on the best reasonably available scientific, technical, demographic, economic, and statistical information and evidence to develop, issue or inform the public of the nature and bases of Federal agency rules and guidance, and for other purposes."

## H.R. 5798 (Garbarino), THE "PROTECTING OUR NATION'S CAPITAL EMERGENCY ACT OF 2023"
