I strongly support the Lake Charles Harbor and Terminal District's request for a time extension for permanent work associated with ongoing recovery efforts from Hurricanes Laura and Delta. A request for an extension, outlined in 44 CFR 206.202 and 206.204, is allowed if the applicant, beyond their ability, has not completed their project within the original work deadline.

Construction delays experienced by the Port of Lake Charles are attributed to extenuating circumstances that resulted from the impacts, responses, and recovery from additional federally declared disasters since Hurricane Laura, including Hurricane Delta (DR-4570-LA) and the Winter Ice Storm Uri (DR-4590-LA), which hindered the recovery process. Granting this time extension will prevent reimbursement issues with GOHSEP related to the date of approval. The following permanent work projects are included in this request:
