I am a Director of 23andMe and Director & Officer of TTAM Research Institute.

I served as the Chief Executive Officer ("CEO") of 23andMe until March 23, 2025, two days after the Special Committee of the Board (the "Special Committee") of 23andMe indicated its plan to pursue a sale of the Company through the chapter 11 bankruptcy process. I resigned so I could pursue an acquisition of the Company as an independent bidder. While I continue to be a member of the Company's Board, I have had no role in the operation or oversight of the Company since I resigned. These functions generally have been delegated to the Special Committee, composed of four other directors. My access to company emails and information is limited.
