Dear Chairman Comer and Ranking Member Garcia:

As President & CEO of the National Urban League and President & CEO of the Greater Washington Urban League, we urge members of this committee to use their time during today's hearing, "Oversight of the District of Columbia" to discuss the myriad ways that Congress could helpfully support the Mayor and the D.C. Council in building a safe, thriving community.

In the past, hearings focused on the District of Columbia have produced narratives that are not only factually inaccurate, but also politically motivated, racially coded, and historically rooted.

A capitol city is supposed to reflect the soul of the nation. From the monuments and memorials to the cultural institutions and the neighborhood businesses, Washington, D.C. is a place where the American identity has been built, tested, and transformed.

Instead of investing in the success of our nation's capital, some Members of Congress have promoted the idea that a federal takeover is necessary to ensure safety and security in the District, while prohibiting the local D.C. government from accessing approximately \$1.1 Billion in local taxpayer funds. Meanwhile, the Trump administration is canceling millions in life-saving grant funding previously committed

to D.C. public schools², violence interruption programs³, housing for low-income residents⁴, and healthcare⁵.

In fact, this week the House of Representatives is pushing ahead with a vote on a package of bills that will erode the rights and dignity of D.C. residents under the guise of "law and order". Bills like the DC CRIMES Act of 2025 (H.R. 4922)7, the District of Columbia Policing Protection Act of 2025 (H.R. 5143)8, and District of Columbia Juvenile Sentencing Reform Act (H.R. 5140)9, will undo the progress the city has made towards reducing street crime, which is at a historic 30-year-low. 10

The challenges cities like D.C. face, from public safety to housing, from education to economic inclusion, demand comprehensive solutions and collaborative leadership. What they do not need are politically charged narratives that demonize communities and invite federal overreach. In the past month, misleading statements from national leadership describing the District as overtaken by "violent gangs," "roving mobs of wild youth," and "drugged-out maniacs" coupled with deployment of the National Guard and additional federal law enforcement personnel evoked a familiar and troubling pattern that will not end in the District.¹¹

This administration has already deployed the National Guard to Los Angeles and surged federal agents to Chicago; while officials escalate their rhetoric and threaten incursions into plurality Black and Brown cities represented by Black mayors, like Baltimore, New Orleans, Oakland, and Memphis. Today's hearing and the floor votes scheduled for the full House of Representatives are test cases for Members of Congress. We urge you to vote against any legislation that undermines the autonomy of these cities and focus on ways the federal government can meaningfully support local communities.

The residents of Washington, D.C. have consistently and explicitly petitioned this body for statehood, and yet, House leadership is determined to undermine the will of the people. We urge Members of Congress to center the marginalized communities they oversee by advancing real solutions and expanding access to economic opportunities. These are proven strategies that will improve life in the District, unlike deploying armed military personnel to the city's streets.
