The individual who I referred to in complaint 18-16264 can be seen clearly in the background of the video in my story at the 50 mark, with the red vest and red hat. He is also the individual blocking my camera and pushing me.

I believe the person who assaulted me on video while most were in back seats is a supervisor. Someone he also ordered another worker to help him get in front of my camera.

I didn't file a complaint against the second person (a younger black man) because while that person did block my view, he never put his hands on me or my camera and he never pushed me.
