



DETAINER ACCEPTANCE TRACKER - LIMITED AND NON-COOPERATIVE INSTITUTIONS

ISSUE:

- 551 institutions do not accept Immigration Detainers, impacting 18 field offices.
- 146 institutions accept Immigration Detainers in a limited fashion, impacting 18 field offices.

BACKGROUND:

To maintain situational awareness of impacts to ICE’s ability to transfer noncitizens from jails/prisons, DHS needs accurate information to identify non-cooperative or limited cooperating Law Enforcement Agencies (LEA) or jurisdictions, to include their policies, that either prevent state or local enforcement agencies from releasing noncitizens into ICE custody or from sharing certain information with ICE officials.

- Prior to January 1, 2020, versions of the Detainer Acceptance Tracker (DAT) requested the following information from field offices: Accepts I-247A? Hold for ICE?, Adequate Notification?
- On January 13, 2020 to prevent subjectivity and skewed limited compliance statistics, CAD modified the criteria in the DAT for the version below:
 - **Non-cooperative:** No - Notification prior to release AND No - Adequate hold time to assume DHS custody
 - **Limited cooperation:** Yes - Notification prior to release AND No - Adequate hold time to assume DHS custody
- On January 24, 2020, the Enforcement CAD tasked the field offices requiring monthly updates to the DAT to provide current information relating to the compliance posture of institutions located in their areas of responsibility (AORs)

Notes: *As part of the tasking to update the DAT monthly, field offices are also requested to add and remove institutions as necessary. As a result of these periodic updates made during each month, the total number of facilities, as well as the total number of non-cooperative and limited cooperation facilities will fluctuate.*
