On <u>Wednesday</u>, <u>December 1</u>, <u>2021</u>, <u>at 10:15 a.m. ET</u>, the Subcommittee on Government Operations will host a Hybrid Hearing on "The Future of Federal Work." The hearing will convene in room 2154 of the Rayburn House Office Building and over Zoom, which has been approved by the House.

Per the Office of Attending Physician's (OAP) guidelines, and in consultation with the Architect of the Capitol, Chief Administrative Officer (CAO), the Sergeant at Arms, and the Committee on House Administration, the hearing room has been reconfigured to comply with social distancing requirements. As a result, seating in the hearing room is extremely limited and may not be able to accommodate all Members at one time. In light of current guidance from Centers for Disease Control and Prevention (CDC) and OAP, all Members and staff must continue to wear masks at all times, regardless of vaccination status. Members may remove their masks only when recognized by the Chair to speak.

Members joining remotely are asked to connect by 9:45 a.m. to ensure their participation and troubleshoot any connectivity issues. Only Members, witnesses and their

counsel, and approved Committee staff are allowed into the Zoom platform. All other staff may watch via livestream on the Committee's <u>website</u>. Members connecting through Zoom will be sent the meeting invitation link via Outlook once RSVP'd.
