Per the Office of the Attending Physician's (OAP) guidelines, and in consultation with the Architect of the Capitol, the Chief Administrative Officer, the Sergeant at Arms, and the Committee on House Administration, the hearing room has been reconfigured to provide for social distancing. As a result, seating in the hearing room is extremely limited and may not be able to accommodate all Members at one time.

In light of current guidance from Centers for Disease Control and Prevention (CDC) and OAP, all Members and staff must wear must properly fitted, medical-grade, filtration face masks (KN95 or N95 masks) masks at all times, regardless of vaccination status. Members may remove their masks only when recognized by the Chair to speak.
