**Members joining the meeting remotely are asked to connect by 12:30 p.m. to ensure their participation and troubleshoot any connectivity issues.** Only Members, witnesses and their counsel, and approved Committee staff are allowed into the Zoom platform. All other staff may watch via livestream on the Committee’s [website](#). Members will be sent the meeting invitation link via Outlook once RSVP’d.

**Members joining the meeting in person** may have to rotate in and out of the hearing room as they do on the House floor, in order to maintain safe distances and not exceed seating

capacity. When rotating out of the hearing room, Members are asked to wipe down their microphones and seating area when they leave their seats. Sanitizing wipes will be available.
