**SUBSTITUTE TO H.R. 8281**

Page 17, line 12, strike “The Secretary” and insert  
“The head of a Federal department or agency”.

Page 21, line 22, strike “Subsection (j)” and insert  
“Subsections (i) and (j)”.

Page 21, beginning line 25, strike “this subsection”  
and insert “such subsections”.

Page 22, line 1, strike “60 days after” and insert  
“60 days prior to”.

Page 23, beginning line 10, strike “if the individual  
is a citizen of the United States” and insert “if the indi-  
vidual is verified as a citizen of the United States pursu-  
ant to section 8(j) of the National Voter Registration Act  
of 1993 (as added by section 2(f))”.
