Page 65, after line 13, insert the following:

3	(a) Enhancements to the Rotation Program.—
4	Section 844(a) of the Homeland Security Act of 2002 (6)
5	U.S.C. 414(a)) is amended as follows:
6	(1) In paragraph (1)—
7	(A) by striking "Not later than 180 days
8	after the date of enactment of this section, the"
9	and inserting "The"; and
10	(B) In paragraph (1), by striking "for em-
11	ployees of the Department" and inserting "for
12	certain personnel within the Department".
13	(2) In paragraph (2)—
14	(A) by redesignating subparagraphs (A)
15	through (G) as subparagraphs (C) through (I),
16	and inserting before subparagraph (C), as so
17	redesignated, the following:
18	"(A) seek to foster greater Departmental
19	integration and unity of effort;

1	"(B) seek to help enhance the knowledge,
2	skills, and abilities of participating personnel
3	with respect to the Department's programs,
4	policies, and activities;";
5	(B) in subparagraph (D), as so redesig-
6	nated, by striking "middle and senior level";
7	and
8	(C) in subparagraph (G), as so redesig-
9	nated, by inserting before "invigorate" the fol-
10	lowing: "seek to improve morale and retention
11	throughout the Department and".
12	(3) In paragraph (3)(B), by striking clause (iii)
13	and redesignating clauses (iv) through (viii) as
14	clauses (iii) through (vii).
15	(4) By redesignating paragraphs (4) and (5) as
16	paragraphs (5) and (6), and inserting after para-
17	graph (3) the following:
18	"(4) Administrative matters.—In carrying
19	out any program established pursuant to this sec-
20	tion, the Secretary shall—
21	"(A) before selecting employees for partici-
22	pation in such program, disseminate informa-
23	tion broadly within the Department about the
24	availability of the program, qualifications for
25	participation in the program, including full-time

1	employment within the employing component or
2	office not less than one year, and the general
3	provisions of the program;
4	"(B) require each candidate for participa-
5	tion in the program to be nominated by the
6	head of the candidate's employing component or
7	office and that the Secretary, or the Secretary's
8	designee, select each employee for the program
9	solely on the basis of relative ability, knowledge,
10	and skills, after fair and open competition that
11	assures that all candidates receive equal oppor-
12	tunity;
13	"(C) ensure that each employee partici-
14	pating in the program shall be entitled to re-
15	turn, within a reasonable period of time after
16	the end of the period of participation, to the po-
17	sition held by the employee, or a corresponding
18	or higher position, in the employee's employing
19	component or office;
20	"(D) require that the rights that would be
21	available to the employee if the employee were
22	detailed from the employing component or office
23	to another Federal agency or office remain
24	available to the employee during the employee
25	participation in the program; and

1	"(E) require that, during the period of
2	participation by an employee in the program,
3	performance evaluations for the employee—
4	"(i) shall be conducted by officials in
5	the employee's office or component with
6	input from the supervisors of the employee
7	at the component or office in which the
8	employee is placed during that period; and
9	"(ii) shall be provided the same
10	weight with respect to promotions and
11	other rewards as performance evaluations
12	for service in the employee's office or com-
13	ponent.".
14	(b) Congressional Notification and Over-
15	SIGHT.—Not later than 120 days after the date of the en-
16	actment of this Act, the Secretary of Homeland Security
17	shall provide information to the Committee on Homeland
18	Security of the House of Representatives and the Com-
19	mittee on Homeland Security and Governmental Affairs
20	of the Senate about the status of the homeland security
21	rotation program authorized by section 844 of the Home-
22	land Security Act of 2002, as amended by this section.
