A BILL

To amend the Homeland Security Act of 2002 to enhance the partnership between the Department of Homeland Security and the National Network of Fusion Centers, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fusion Center En-
- 5 hancement Act of 2015".

1	SEC. 2. DEPARTMENT OF HOMELAND SECURITY FUSION
2	CENTER PARTNERSHIP INITIATIVE.
3	(a) In General.—Section 210A of the Homeland
4	Security Act of 2002 (6 U.S.C. 124h) is amended—
5	(1) by amending the section heading to read as
6	follows:
7	"SEC. 210A. DEPARTMENT OF HOMELAND SECURITY FU-
8	SION CENTER PARTNERSHIP INITIATIVE.";
9	(2) in subsection (a), by adding at the end the
10	following new sentence: "Beginning on the date of
11	the enactment of the Fusion Center Enhancement
12	Act of 2015, such Initiative shall be known as the
13	'Department of Homeland Security Fusion Center
14	Partnership Initiative'.";
15	(3) by amending subsection (b) to read as fol-
16	lows:
17	"(b) Interagency Support and Coordination.—
18	Through the Department of Homeland Security Fusion
19	Center Partnership Initiative, in coordination with prin-
20	cipal officials of fusion centers in the National Network
21	of Fusion Centers and the officers designated as the
22	Homeland Security Advisors of the States, the Secretary
23	shall—
24	"(1) coordinate with the heads of other Federal
25	departments and agencies to provide operational and

1	intelligence advice and assistance to the National
2	Network of Fusion Centers;
3	"(2) support the integration of fusion centers
4	into the information sharing environment;
5	"(3) support the maturation and sustainment
6	of the National Network of Fusion Centers;
7	"(4) reduce inefficiencies and maximize the ef-
8	fectiveness of Federal resource support to the Na-
9	tional Network of Fusion Centers;
10	"(5) provide analytic and reporting advice and
11	assistance to the National Network of Fusion Cen-
12	ters;
13	"(6) review information within the scope of the
14	information sharing environment, including home-
15	land security information, terrorism information,
16	and weapons of mass destruction information, that
17	is gathered by the National Network of Fusion Cen-
18	ters and incorporate such information, as appro-
19	priate, into the Department's own such information;
20	"(7) provide for the effective dissemination of
21	information within the scope of the information
22	sharing environment to the National Network of Fu-
23	sion Centers;
24	"(8) facilitate close communication and coordi-
25	nation between the National Network of Fusion

1	Centers and the Department and other Federal de-
2	partments and agencies;
3	"(9) provide the National Network of Fusion
4	Centers with expertise on Department resources and
5	operations;
6	"(10) coordinate the provision of training and
7	technical assistance to the National Network of Fu-
8	sion Centers and encourage such fusion centers to
9	participate in terrorism threat-related exercises con-
10	ducted by the Department;
11	"(11) ensure, to the greatest extent practicable,
12	that support for the National Network of Fusion
13	Centers is included as a national priority in applica-
14	ble homeland security grant guidance;
15	"(12) ensure that each fusion center in the Na-
16	tional Network of Fusion Centers has a privacy pol-
17	icy approved by the Chief Privacy Officer of the De-
18	partment and a civil rights and civil liberties policy
19	approved by the Officer for Civil Rights and Civil
20	Liberties of the Department;
21	"(13) coordinate the nationwide suspicious ac-
22	tivity report initiative to ensure information gath-
23	ered by the National Network of Fusion Centers is
24	incorporated as appropriate;

1	"(14) lead Department efforts to ensure fusion
2	centers in the National Network of Fusion Centers
3	are the primary focal points for the sharing of home-
4	land security information, terrorism information,
5	and weapons of mass destruction information with
6	State and local entities to the greatest extent prac-
7	ticable;
8	"(15) develop and disseminate best practices on
9	the appropriate levels for staffing at fusion centers
10	in the National Network of Fusion Centers of quali-
11	fied representatives from State, local, tribal, and ter-
12	ritorial law enforcement, fire, emergency medical,
13	and emergency management services, and public
14	health disciplines, as well as the private sector; and
15	"(16) carry out such other duties as the Sec-
16	retary determines appropriate.";
17	(4) in subsection (c)—
18	(A) by striking so much as precedes para-
19	graph (3)(B) and inserting the following:
20	"(c) RESOURCE ALLOCATION.—
21	"(1) Information sharing and personnel
22	ASSIGNMENT.—
23	"(A) Information sharing.—The Under
24	Secretary for Intelligence and Analysis shall en-
25	sure that, as appropriate—

1	"(i) fusion centers in the National
2	Network of Fusion Centers have access to
3	homeland security information sharing sys-
4	tems; and
5	"(ii) Department personnel are de-
6	ployed to support fusion centers in the Na-
7	tional Network of Fusion Centers.
8	"(B) Personnel Assignment.—Depart-
9	ment personnel referred to in subparagraph
10	(A)(ii) may include the following:
11	"(i) Intelligence officers.
12	"(ii) Intelligence analysts.
13	"(iii) Other liaisons from components
14	and offices of the Department, as appro-
15	priate.
16	"(2) Sources of support.—
17	"(A) In General.—Information shared
18	and personnel assigned pursuant to paragraph
19	(1) may be shared or provided, as the case may
20	be, by the following Department components
21	and offices, in coordination with the respective
22	component or office head and in consultation
23	with the principal officials of fusion centers in
24	the National Network of Fusion Centers:

1	"(i) The Office of Intelligence and
2	Analysis.
3	"(ii) The Office of Infrastructure Pro-
4	tection.
5	"(iii) The Transportation Security
6	Administration.
7	"(iv) U.S. Customs and Border Pro-
8	tection.
9	"(v) U.S. Immigration and Customs
10	Enforcement.
11	"(vi) The Coast Guard.
12	"(vii) Other components or offices of
13	the Department, as determined by the Sec-
14	retary.
15	"(B) Coordination with other fed-
16	ERAL AGENCIES.—The Under Secretary for In-
17	telligence and Analysis shall coordinate with ap-
18	propriate officials throughout the Federal Gov-
19	ernment to ensure the deployment to fusion
20	centers in the National Network of Fusion Cen-
21	ters of representatives with relevant expertise of
22	other Federal departments and agencies.
23	"(3) RESOURCE ALLOCATION CRITERIA.—
24	"(A) IN GENERAL.—The Secretary shall
25	make available criteria for sharing information

1	and deploying personnel to support a fusion
2	center in the National Network of Fusion Cen-
3	ters pursuant to paragraph (1)."; and
4	(B) in paragraph (4)(B), in the matter
5	preceding clause (i), by inserting "in which
6	such fusion center is located" after "region";
7	(5) in subsection (d)—
8	(A) in paragraph (3), by striking "and" at
9	the end;
10	(B) in paragraph (4)—
11	(i) by striking "government" and in-
12	serting "governments"; and
13	(ii) by striking the period at the end
14	and inserting "; and"; and
15	(C) by adding at the end the following new
16	paragraph:
17	"(5) utilize Department information, including
18	information held by components and offices, to de-
19	velop analysis focused on the mission of the Depart-
20	ment under section 101(b).";
21	(6) in subsection (e)—
22	(A) by amending paragraph (1) to read as
23	follows:
24	"(1) In General.—To the greatest extent
25	practicable, the Secretary shall make it a priority to

1	allocate resources, including deployed personnel,
2	under this section from U.S. Customs and Border
3	Protection, U.S. Immigration and Customs Enforce-
4	ment, and the Coast Guard to support fusion centers
5	in the National Network of Fusion Centers located
6	in jurisdictions along land or maritime borders of
7	the United States in order to enhance the integrity
8	of and security at such borders by helping Federal,
9	State, local, tribal, and territorial law enforcement
10	authorities to identify, investigate, and otherwise
11	interdict persons, weapons, and related contraband
12	that pose a threat to homeland security."; and
13	(B) in paragraph (2), in the matter pre-
14	ceding subparagraph (A), by striking "partici-
15	pating State, local, and regional";
16	(7) in subsection (j)—
17	(A) in paragraph (4), by striking "and" at
18	the end;
19	(B) by redesignating paragraph (5) as
20	paragraph (6); and
21	(C) by inserting after paragraph (4) the
22	following new paragraph:
23	"(5) the term 'National Network of Fusion
24	Centers' means a decentralized arrangement of fu-
25	sion centers intended to enhance individual State

1	and urban area fusion centers' ability to leverage the
2	capabilities and expertise of all fusion centers for the
3	purpose of enhancing analysis and homeland secu-
4	rity information sharing nationally; and"; and
5	(8) by striking subsection (k).
6	(b) ACCOUNTABILITY REPORT.—Not later than one
7	year after the date of the enactment of this Act and annu-
8	ally thereafter through 2022, the Under Secretary for In-
9	telligence and Analysis of the Department of Homeland
10	Security shall report to the Committee on Homeland Secu-
11	rity of the House of Representatives and the Committee
12	on Homeland Security and Governmental Affairs of the
13	Senate on the efforts of the Office of Intelligence and
14	Analysis of the Department and other relevant compo-
15	nents and offices of the Department to enhance support
16	provided to fusion centers in the National Network of Fu-
17	sion Centers, including meeting the requirements specified
18	in section 210A of the Homeland Security Act of 2002
19	(6 U.S.C. 124h), as amended by subsection (a) of this sec-
20	tion.
21	(c) Clerical Amendment.—The table of contents
22	in section 1(b) of such Act is amended by striking the
23	item relating to section 210A and inserting the following
24	new item:

"Sec. 210A. Department of Homeland Security Fusion Centers Initiative.".

- 2 regulation to the "Department of Homeland Security
- 3 State, Local, and Regional Fusion Center Initiative' shall
- 4 be deemed to be a reference to the "Department of Home-
- 5 land Security Fusion Center Initiative".
