1	SEC. 223. DEPARTMENT LEADERSHIP COUNCIL.
2	(a) In General.—Subtitle H of title VIII of the
3	Homeland Security Act of 2002 is amended by adding at
4	the end the following new section:
5	"SEC. 890B. DEPARTMENT LEADERSHIP COUNCIL.
6	"(a) Department Leadership Council.—
7	"(1) Establishment.—The Secretary may es-
8	tablish a Department leadership council as the Sec-
9	retary determines necessary to ensure coordination
10	and improve programs and activities of the Depart-
11	ment.
12	"(2) Function.—A Department leadership
13	council shall—
14	"(A) serve as coordinating forums;
15	"(B) advise the Secretary and Deputy Sec-
16	retary on Department strategy, operations, and
17	guidance; and

1	"(C) consider and report on such other
2	matters as the Secretary or Deputy Secretary
3	may direct.
4	"(3) Relationship to other forums.—The
5	Secretary or Deputy Secretary may delegate the au-
6	thority to direct the implementation of any decision
7	or guidance resulting from the action of a Depart-
8	ment leadership council to any office, component, co-
9	ordinator, or other senior official of the Department.
10	"(4) Mission.—In addition to other matters
11	assigned to it by the Secretary and Deputy Sec-
12	retary, a leadership council shall—
13	"(A) identify, assess, and validate joint re-
14	quirements (including existing systems and as-
15	sociated capability gaps) to meet mission needs
16	of the Department;
17	"(B) ensure that appropriate efficiencies
18	are made among life-cycle cost, schedule, and
19	performance objectives, and procurement quan-
20	tity objectives, in the establishment and ap-
21	proval of joint requirements; and
22	"(C) make prioritized capability rec-
23	ommendations for the joint requirements vali-
24	dated under subparagraph (A) to the Secretary,
25	the Deputy Secretary, or the chairperson of a

1	Department leadership council designated by
2	the Secretary to review decisions of the leader-
3	ship council.
4	"(5) Chairperson.—The Secretary shall ap-
5	point a chairperson of a leadership council, for a
6	term of not more than 2 years, from among senior
7	officials from components of the Department or
8	other senior officials as designated by the Secretary.
9	"(6) Composition.—A leadership council shall
10	be composed of senior officials representing compo-
11	nents of the Department and other senior officials
12	as designated by the Secretary.
13	"(7) Relationship to future years home-
14	LAND SECURITY PROGRAM.—The Secretary shall en-
15	sure that the Future Years Homeland Security Pro-
16	gram required under section 874 is consistent with
17	any recommendations of a leadership council re-
8	quired under paragraph (2)(C), as affirmed by the
9	Secretary, the Deputy Secretary, or the chairperson
20	of a Department leadership council designated by
21	the Secretary under that paragraph.".
22	(b) CLERICAL AMENDMENT.—The table of contents
23	in section 1(b) of such Act is amended by inserting after
24	the item relating to section 890A the following new item:
