At the end of title V, insert the following:

1 **Subtitle H—Strategic 5-year Tech-**

5 **SEC. 591. INFORMATION REQUIRED TO BE SUBMITTED TO**
6 **CONGRESS UNDER THE STRATEGIC 5-YEAR**
7 **TECHNOLOGY INVESTMENT PLAN OF THE**
8 **TRANSPORTATION SECURITY ADMINISTRA-**
9 **TION.**

10 (a) **ADDITIONAL INFORMATION REQUIRED.**—Section
11 1611 of the Homeland Security Act of 2002 (6 U.S.C.
12 563) is amended—

13 (1) in subsection (g)—

14 (A) in the matter preceding paragraph (1),
15 by striking “biennially” and inserting “annu-
16 ally”;

17 (B) in paragraph (1), by striking “and”;

18 (C) in paragraph (2), by striking the pe-
19 riod and inserting “; and”;

1 (D) by adding at the end the following new
2 paragraph:

3 “(3) information about acquisitions completed
4 during the fiscal year preceding the fiscal year dur-
5 ing which the report is submitted.”; and

6 (2) by adding at the end the following new sub-
7 sections:

8 “(h) NOTICE OF COVERED CHANGES TO PLAN.—

9 “(1) NOTICE REQUIRED.—The Administrator
10 shall submit to the Committee on Commerce,
11 Science, and Transportation of the Senate and the
12 Committee on Homeland Security of the House of
13 Representatives notice of any covered change to the
14 Plan by not later than 90 days after the date on
15 which the change is made.

16 “(2) DEFINITION OF CHANGE.—In this sub-
17 section, the term ‘covered change’ means an increase
18 or decrease in the dollar amount allocated to the
19 procurement of a technology or an increase or de-
20 crease in the number of a technology.”.

21 (b) REPORT ON EQUIPMENT IN OPERATION POST-
22 LIFE-CYCLE.—Not later than 90 days after the date of
23 the enactment of this Act, the Administrator of the Trans-
24 portation Security Administration shall submit to the
25 Committee on Commerce, Science, and Transportation of

1 the Senate and the Committee on Homeland Security of
2 the House of Representatives a report describing any
3 equipment of the Transportation Security Administration
4 that is in operation after—

5 (1) the end of the life-cycle of the equipment
6 specified by the manufacturer of the equipment; or

7 (2) the end of the useful life projection for the
8 equipment under the strategic 5-year technology in-
9 vestment plan of the Transportation Security Ad-
10 ministration, as required by section 1611 of the
11 Homeland Security Act of 2002 (6 U.S.C. 563).

12 (c) NOTICE TO AIRPORTS AND AIRLINES.—Upon the
13 enactment of this Act, the Administrator of the Transpor-
14 tation Security Administration shall notify airports and
15 airlines of any changes to the 5-year technology invest-
16 ment plan of the Transportation Security Administration.
