1SEC. 2. WEB-BASED SECURE FLIGHT COST AND FEASI-2BILITY STUDY.

Not later than 120 days after the date of the enactment of this Act, the Administrator of the Transportation
Security Administration shall conduct a study to determine the cost and feasibility of establishing web-based access to Secure Flight for commercial charter air carriers.
SEC. 3. SCREENING IN AREAS OTHER THAN PASSENGER
TERMINALS.

(a) IN GENERAL.—The Administrator of the Transportation Security Administration is authorized to provide
screening services to a commercial charter air carrier in
areas other than primary passenger terminals of airports
upon the request of such carrier.

(b) REQUEST.—A commercial charter air carrier that
wants screening services to be provided to such carrier in
an area other than a primary passenger terminal shall request the Federal Security Director for the airport at
which such services are requested.

20 (c) AVAILABILITY.— A Federal Security Director
21 may elect to provide screening services under this section
22 if such services are available.

(d) AGREEMENTS.—The Administrator of the Transportation Security Administration shall enter into an
agreement with a commercial charter air carrier for compensation from such carrier requesting the use of screen-

ing services under this section for all reasonable costs in
 addition to overtime costs that are incurred in the provi sion of such services.

LECT AVIATION SECURITY TOPICS.

6 Not later than 120 days after the date of the enact-7 ment of this Act, the Administrator of the Transportation 8 Security Administration, in consultation with the Aviation 9 Security Advisory Committee, shall submit to the Committee on Homeland Security of the House of Representa-10 tives and the Committee on Commerce, Science, and 11 12 Transportation of the Senate an implementation plan, including an implementation schedule, for the following rec-13 ommendations adopted by the Aviation Security Advisory 14 Committee: 15

- 16 (1) The recommendation regarding general
 17 aviation access to Ronald Reagan Washington Na18 tional Airport, as adopted on February 17, 2015.
- 19 (2) The recommendation regarding the vetting
 20 of persons seeking flight training in the United
 21 States, as adopted on July 28, 2016.

(3) Any other such recommendations relevant
to the security of general aviation adopted before the
date of the enactment of this Act.

1 SEC. 5. DESIGNATED STAFFING FOR GENERAL AVIATION.

2 The Administrator of the Transportation Security
3 Administration is authorized to designate not fewer than
4 one full time employee of the Administration to be respon5 sible for engagement with general aviation stakeholders
6 and manage issues related to general aviation.
